If you have other family members on the plan, each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible.
<b>Are there services covered before you meet your <a href="#">deductible</a>?</b>	Yes, Preventive Care, Office Visits, Emergency Medical Transportation, Urgent Care, Generic Prescription Drugs, Dental Class 1, Pediatric Vision	This plan covers some items and services even if you haven't yet met the deductible amount.
