What is the overall deductible ?	\$8,550 individual / \$17,100 family aggregate. Co-insurance and co-payments do not apply to the deductible . This benefit combines your prescription drug and medical deductibles .	Generally, you must pay all of the costs from providers up to the deductible amount each plan year before this plan begins to pay. If you have other family members on the policy, the overall family deductible must be met before the plan begins to pay. Your plan year: 01/01/2021 through 12/31/2021.
Are there services covered before you meet your deductible ?	Yes, preventive care , dental class I, the first three primary care, mental health and substance abuse office visits (including routine lab services) combined up to a total of nine visits per family, wellness drugs	This plan covers some items and services even if you haven't yet met the deductible amount.
