They can answer your questions, including how to enroll in Medicare. They can also help you choose a Medicare Part D prescription drug plan that works best for you.

You may also qualify for State of Vermont programs, including Medicaid, that help reduce the cost of Medicare. Call Green Mountain Care at 1-800-250-8427 to find out more information and get help applying for those programs. You will need to fill out a paper application to apply. If you need help filling out the application, you can call Green Mountain Care or the Senior HelpLine.
