What is the overall deductible ?	\$3,100 individual / \$6,200 family stacked. Co-insurance and co-payments do not apply to the deductible .	Generally, you must pay all of the costs from providers up to the deductible amount each plan year before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible . Your plan year: 01/01/2021 through 12/31/2021.
Are there services covered before you meet your deductible ?	Yes, preventive care , office visits, urgent care , emergency medical transportation , dental class I and generic prescription drugs	This plan covers some items and services even if you haven't yet met the deductible amount. But a co-payment or co-insurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . What is the out-of-pocket limit for this plan ?	\$6,750 individual plan . Family plans have an individual out-of-pocket limit of \$6,750 and \$13,500 stacked family. The out-of-pocket limit is the most you could pay in a plan year for covered services.
