What is the overall <a href="#">deductible</a> ?	\$2,100 individual / \$4,200 family aggregate.  <a href="#">Co-insurance</a> and <a href="#">co-payments</a> do not apply to the <a href="#">deductible</a> . This benefit combines your prescription drug and medical <a href="#">deductibles</a> .	Generally, you must pay all of the costs from providers up to the <a href="#">deductible</a> amount each <a href="#">plan</a> year before this <a href="#">plan</a> begins to pay. If you have other family members on the policy, the overall family <a href="#">deductible</a> must be met before the <a href="#">plan</a> begins to pay. Are there services covered before you meet your <a href="#">deductible</a> ? What is the <a href="#">out-of-pocket limit</a> for this <a href="#">plan</a> ?	\$5,700 individual <a href="#">plan</a> . Family plans have an individual <a href="#">out-of-pocket limit</a> of \$7,900 and \$11,400 aggregate family. <a href="#">Prescription drugs</a> : \$1,350 individual <a href="#">plan</a> / \$2,700 family aggregate.
